*) Note regarding **storage contracts** concluded by S.N.G.N. ROMGAZ S.A. with S.C. GDF SUEZ Energy Romania S.A. for **2015-2016 cycle**:

- The scope of contract **8311/2015** (reported on June 2, 2015) is the supply of UGS services for gas representing the minimum stock obligation for the **regulated market segment**.
- The scope of contract **8465/2015 – STOCK CONTRACT FOR GAS REMAINING FROM 2014-2015 CYCLE** – is the supply of UGS services for natural gas volumes destined for heating producers as final customers but only for natural gas volumes used for heat generation in cogeneration plants and in heating plants destined for the population’s consumption, **free market segment**.
- The scope of contract **8466/2015** is the supply of UGS services for gas destined to secure consumption for heating producers as final customers but only for gas volumes used for heat generation in cogeneration plants and in heating plants destined for the population’s consumption, **free market segment**.
